#### **USBLN®** Affiliate of the Year

The outstanding BLN Affiliate of the Year is one that has demonstrated exemplary efforts in promoting the vision, mission and spirit of the USBLN<sup>®</sup>. As a result of this BLN Affiliate's efforts, employers and their communities understand, utilize, and benefit from the valuable resources that people with disabilities present in the workplace, supply chain and marketplace. #### **USBLN<sup>®</sup> Employer of the Year**

There are two categories for Employer of the Year award – one for companies with over 1000 employees and one for companies with less than 1000 employees. Companies are recognized for exemplary policies, strategies and

initiatives that have resulted in measurable results in the areas of disability inclusiveness in the workplace, marketplace and supply chain. Note: Employer shall mean all employers except non-profit service providers and government agencies. [DOC]

### **USBLN®** Top Corporation for Disability-Owned Businesses Award

The "Top Corporation for Disability-Owned Businesses" award is presented to the corporation or government agency that has demonstrated outstanding inclusion of USBLN<sup>®</sup> certified disability-owned businesses, including businesses owned by service disabled veteran-owned firms, and demonstrated commitment to disability business inclusion in their supply chain processes and corporate supplier diversity program. #### **USBLN®** Advocate of the Year – Supply Chain Inclusion

This award recognizes the individual advocate and/or procurement champion, who has provided exceptional support in the development of USBLN<sup>®</sup> certified Disability-Owned Business Enterprises- DOBE<sup>®</sup>s (including service-disabled veteran owned businesses) and the USBLN<sup>®</sup> Disability Supplier Diversity Program<sup>®</sup> (DSDP). The "Advocate of the Year-Supply Chain Inclusion" is someone who has demonstrated outstanding commitment to the utilization and growth of disability-owned businesses, including businesses owned by service-disabled veterans. ## **<u>USBLN<sup>®</sup> Supplier of the Year</u>**

This award recognizes the USBLN® certified Disability-Owned Business Enterprise (DOBE<sup>®</sup>) that has provided excellent service and distinguished itself and its business through its business practices and serves as a role model for disability business inclusion in the supply chain. Note: This category is designed for Business members to recognize disability suppliers in their supply chain. [DOC]
